Dear Congressman Donald Payne, Jr.,

We write in support of the Amputation Reduction and Compassion (“ARC”) Act (H.R. XXXX). This crucial piece of federal legislation seeks to address rising rates of preventable amputations that occur every day in the United States. In doing so, and in preventing these unnecessary amputations, this legislation presents a real opportunity to save lives.

Despite numerous medical advances over the past decade, rates of amputations are on the rise. In fact, every three minutes in America, a person with diabetes has a limb amputated. This rate is 75 percent higher than it was just less than a decade ago. What’s worse – rates of amputations vary by race and ethnicity. In fact, rates of amputations are as much as four times higher among black Americans than in non-Hispanic white Americans. Five-year mortality rates for those undergoing a major amputation are worse than many forms of cancer.

So, for some, an amputation procedure can be a death sentence even though nearly 90 percent of these procedures are preventable through earlier interventions, better diagnostics and screenings for conditions that can lead to an amputation, and other engagement opportunities.

The ARC Act fixes this.

Specifically, this legislation will:

- Increase provider awareness and education on opportunities to prevent amputations, including through the creation of a peripheral artery disease (PAD) education program through the United States Department of Health and Human Services;
- Increase access to diagnostics aimed at identifying conditions that can lead to amputation by providing coverage for PAD screenings of at-risk beneficiaries in Medicare and Medicaid;
- Require the development of quality metrics among payers and facilities that can prevent amputations; and
- Provide access to amputation prevention services through the development of a voluntary pilot program, including through patient risk medication and management approaches, early screening and detection, ongoing surveillance, testing, and interventions for PAD and associated conditions.

This legislation provides opportunities to reduce tens of thousands of amputations that occur every year in the United States. In doing so, the legislation will save lives.

We thank you for your leadership on this important cause and look forward to working with your office(s) to have this legislation enacted.
